Easy Steps to claim a refund

**VAT
REFUND**
FOR **TOURISTS**

STEP 1

SHOPPING



- Shop at the store *displaying* 
- *Spend at least 2,000 baht* (VAT included) in the same store on the same day.
- Check passport number on tax invoices.

STEP 2

CUSTOMS PROCEDURE



- **Stamped** by Customs must show all goods purchased if $\geq 5,000$ /person on departure date (*trip by trip*)
- Tourists must carry *luxury goods* and present to VAT Refund officer at counter after passing immigration.

STEP 3

REFUNDING



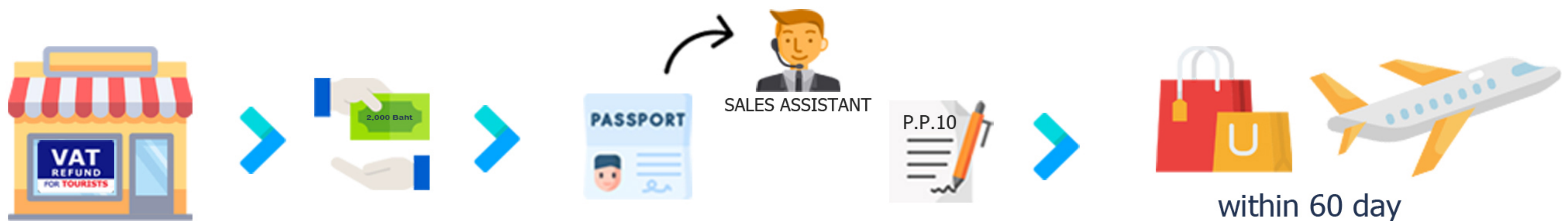
- Show *luxury goods* value of 10,000 baht or more per item.
- Claim a VAT Refund by
 - Counter VAT refund at airport
 - Thailand VRT Application
 - Post ($\geq 30,000$ baht)
 - Downtown agents



VAT REFUND FOR TOURISTS CONDITIONS



- GOODS MUST BE PURCHASED FROM STORES DISPLAYING THE "VAT REFUND FOR TOURISTS" SIGN.
- GOODS MUST BE PURCHASED **AT LEAST 2,000 BAHT** (VAT INCLUDED) PER DAY PER STORE.
- ON THE PURCHASING DATE, **TOURISTS MUST PRESENT PASSPORT AND ASK THE SALES ASSISTANT TO ISSUE THE VAT REFUND APPLICATION FOR TOURISTS FORM (P.P.10) WITH THE ORIGINAL TAX INVOICES. PLEASE ENSURE THAT YOUR PASSPORT NUMBER IS CORRECT.**
- GOODS MUST TAKE OUT OF THAILAND WITH THE TRAVELER **WITHIN 60 DAYS** FROM THE DATE OF PURCHASE.



ON DEPARTURE DATE

- IF THE **TOTAL VALUE OF YOUR PURCHASE IS 5,000 BAHT OR MORE** THE TOURISTS MUST PRESENT THE GOODS, VAT REFUND APPLICATION FOR TOURISTS FORM (P.P.10) AND ORIGINAL TAX INVOICES TO A CUSTOMS OFFICER FOR INSPECTION BEFORE CHECK-IN.
- IN CASE OF LUXURY GOODS (**JEWELRY, GOLD, ORNAMENTS, WATCHES, EYEGLASSES, PEN, MOBILE OR SMART PHONE, LAPTOP AND TABLET, HANDBAG, BELT** OF WHICH THE VALUE IS 10,000 BAHT OR MORE PER ITEM AND CARRY-ON GOODS WHICH THE VALUE IS 50,000 BAHT OR MORE PER ITEM. THE **TOURIST IS REQUIRED TO HAND CARRY AND SHOW THE GOODS AGAIN AT THE VAT REFUND FOR TOURISTS OFFICE, AFTER PASSING THE IMMIGRATION CHECKPOINT.**
- TOURISTS CAN CLAIM A VAT REFUND AT THE VAT REFUND FOR TOURISTS COUNTER AT AN INTERNATIONAL AIRPORT, OR MAIL THE DOCUMENTS TO THE REVENUE DEPARTMENT OF THAILAND.

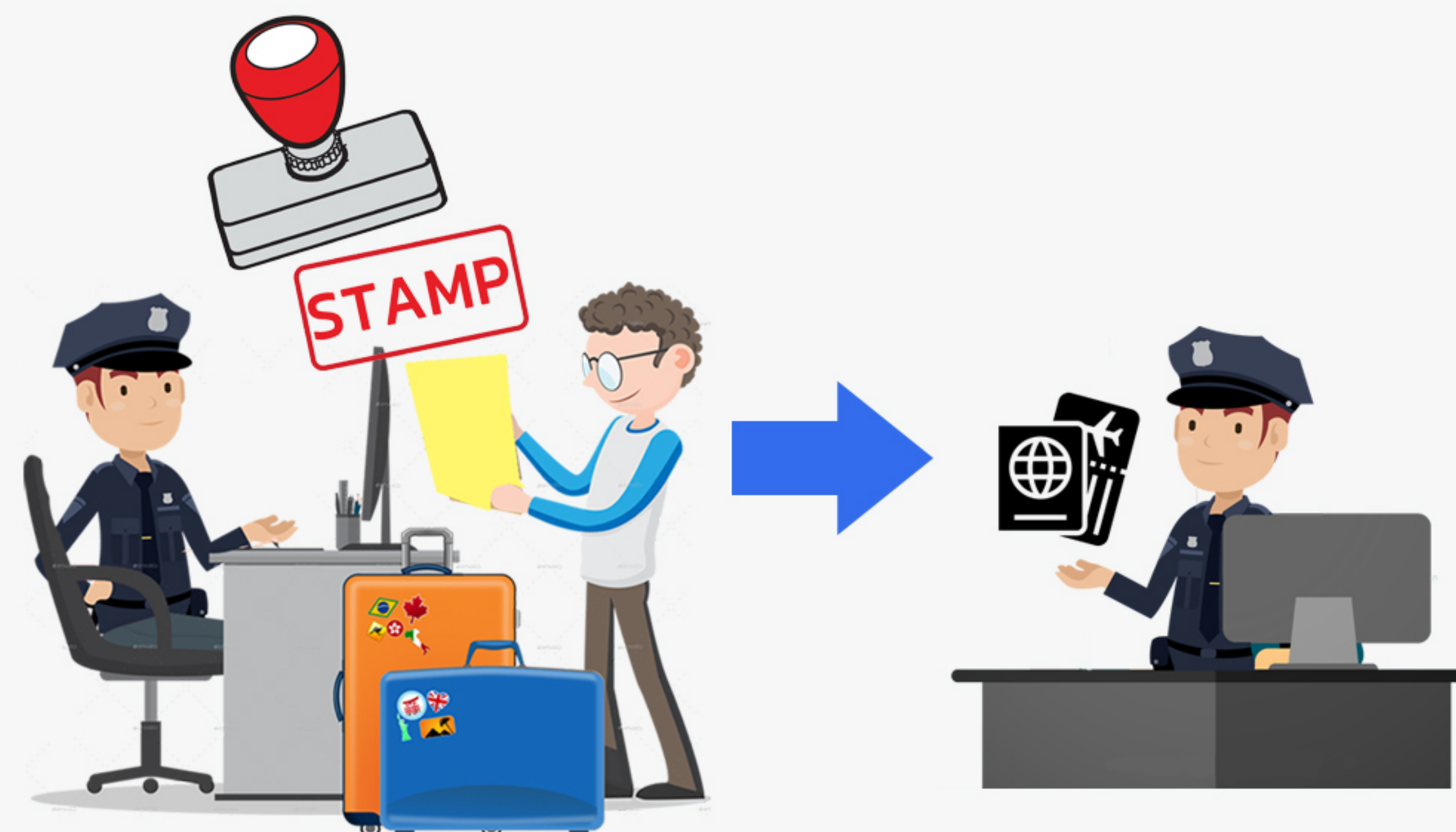

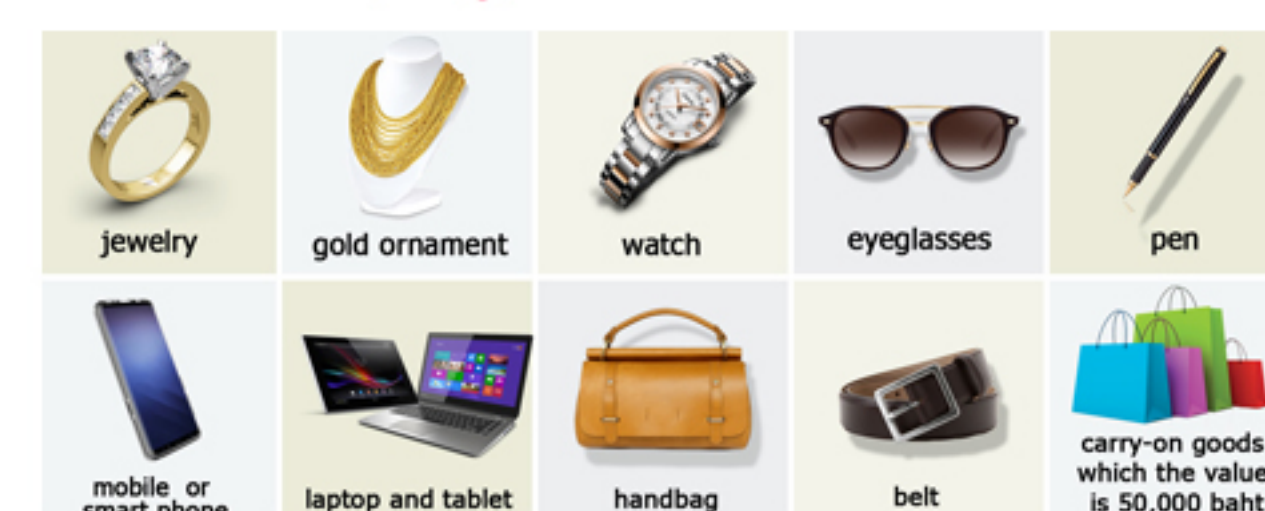

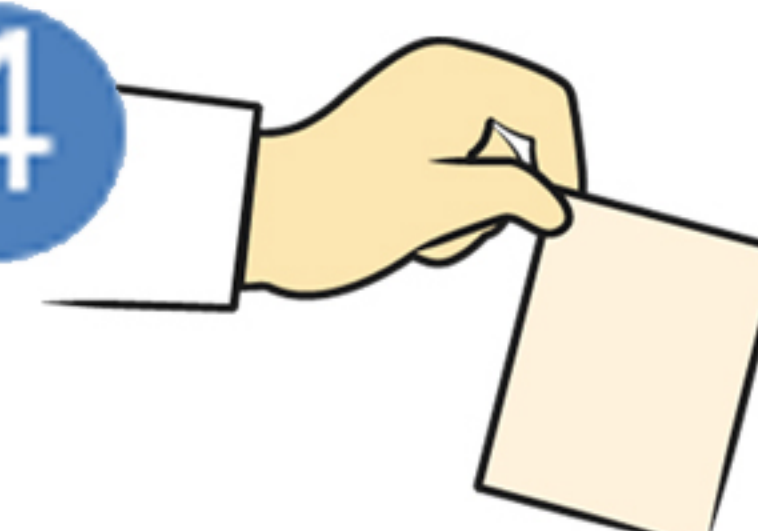
